### About the EIFLE Awards:

Nominations for the 2018 EIFLE Awards are open to the general public. Recipients will be honored at the Awards Dinner to be held on April 09, 2018 during the Annual Conference on Financial Education in Orlando, FL. Award categories include Educator, Organization, Book, Education Program, Field Research, Instructional Game and Legacy. Self nominations are acceptable.

### Content must:

- Use concise language and age/ability appropriate vocabulary;
- Clearly define technical terms, abbreviations and acronyms;
- Be relevant to target audiences;
- Appeal to multiple learning styles;
- Be a book available for purchase by the general public in any format;
- Be informative and unbiased in nature;
- Present content in an objective and neutral tone;
- Provide accurate information; and
- Not deceive or mislead the reader.

### Instructions for Children's Book Nominations:

- 1. Complete Nomination Package:** Please attach one completed package for each Book submitted. Be sure to indicate the Book award category for which you are applying.
- 2. Complete Questionnaire:** Please complete it in its entirety. Nominations received with incomplete questionnaires will not be considered.
- 3. Submit Book:** Submit one copy of nominated program.
- 4. Submit Supporting Documentation:** Submit any relevant supporting documentation about the nominated Book.
- 5. Submit Nomination Fee:** Nominations received without payment will not be considered.
